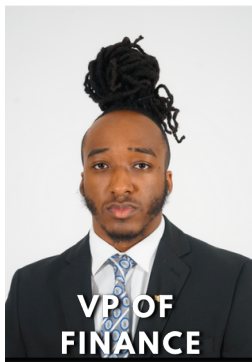

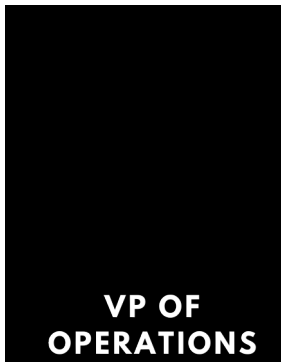

General Health and Safety:

(Please ensure that you read these rules in full. All rules will be enforced once signature is applied.)

Appropriate swimwear is required at all times. **(NO CUT-OFFS) White T-shirts (wife-beaters) only, but must not hang below hips. NO GLASS** of any kind on Deck Area is allowed on the property. Also, **NO CONTROLLED SUBSTANCE** allowed on Club property All food must be consumed in the picnic area, behind the roped area. Members and guests are **REQUIRED** to clean up their own trash. No running, ball playing, dunking, boisterous or rough play (except supervised water sports) is permitted in the pool or on the deck. Includes ball bouncing and skateboarding on deck or any cement area around the pool. Floating equipment, including life preservers of all types,

may be prohibited in the main pool at the discretion of the manager on duty. Use of the pool facilities shall be refused to anyone with skin abrasions, cold, cough, extremely inflamed eyes, infections or wearing bandages. Spitting in the pool or anywhere within the pool facility is prohibited. Blowing of the nose in the pool is also prohibited. Profanity is prohibited. Radios may not interfere with other member's enjoyment of the pool. Keep it low to your immediate area or wear earphones. All persons, especially children, are requested to use the toilet facilities before entering the pool and whenever necessary thereafter. Parents must supervise small children in the bathrooms. Urinating in the pool is cause for revocation of membership at the discretion of the Board of Directors. Children may not be left unattended and the supervision of such children shall be the responsibility of their parents. **Any gathering larger than 10 people must make a reservation at least 24 hours in advance to ensure that we have proper staffing.**

REFUNDS: No refunds will be granted after 7 days from receipt of payment.

RULES HAVING SPECIFIC APPLICATION TO CHILDREN: • All children are encouraged to use bathroom facilities before entering the pool. • All children under age 10 must be accompanied by an adult member (age 18 or over) whenever on Pool property and especially in the pool area and shall not be left unattended at any time. • Children between the ages of 8 and 14 may swim alone provided they have passed the basic swimming test. The pool manager may close the pool at any time, in the interest of health and safety. The lifeguards shall strictly enforce the rules governing the diving boards and lap lane. The pool will be cleared immediately in the event of an emergency. (Three whistle-blows in quick succession). All bathers must take a thorough cleansing shower before entering the pool. All members and guests shall start to exit the facilities by 7:45 p.m. Gates will close at 8:00 p.m.
